The Herald Worldwide Technology Fund (HWTF) is an Open Ended Investment Company (OEIC) that seeks to achieve capital growth, in excess of the average, by investing in quoted companies in the technology, communications and multi-media sectors. As its name suggests, the Fund invests in companies worldwide, but especially North America and the UK.

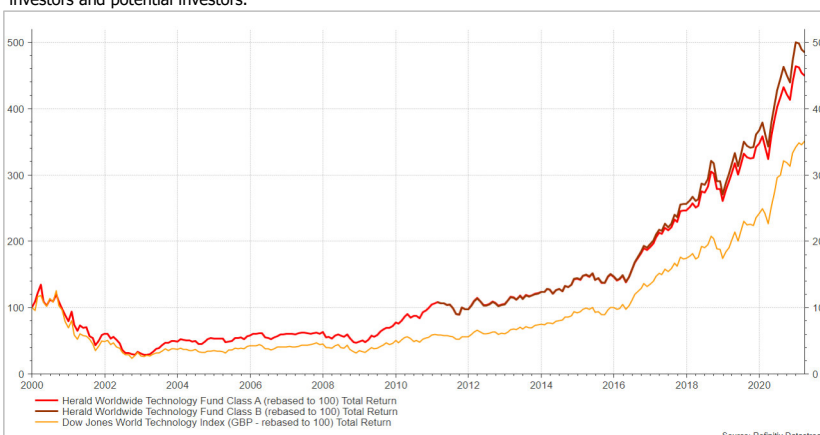

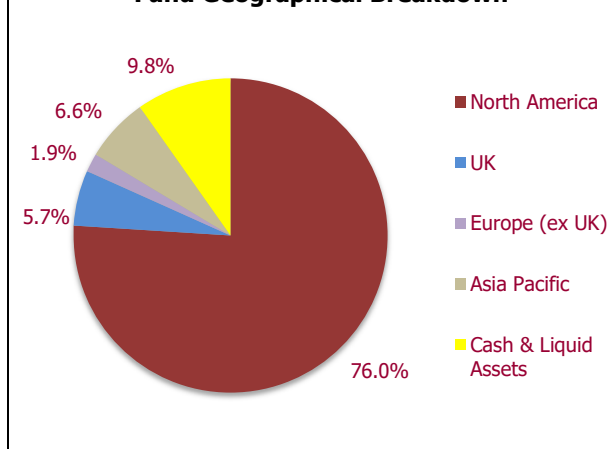

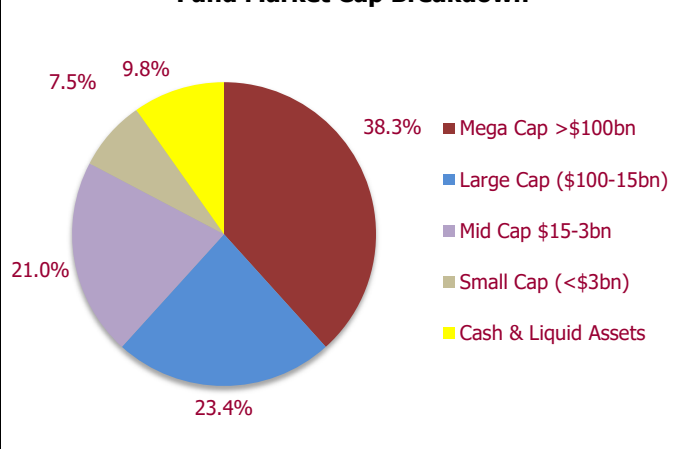

Fund Manager Comment

In March, with fears of inflation, there was a sharp rotation in the financial markets, away from high duration assets towards lower duration assets. This was reflected in the performance of stock in our portfolio as well. Within our portfolio NetApp, Arrow Electronics, and Leidos performed strongly, while higher rated companies, such as Varonis Systems, Cloudera, Medallia suffered. We remain positive on the outlooks for Varonis Systems, Cloudera, and Medallia. All have strong management teams and are investing to benefit from workloads transitioning to the cloud.

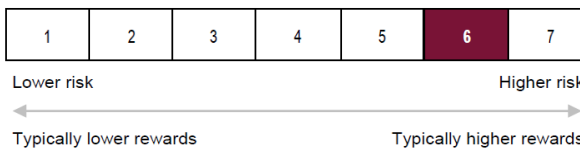
