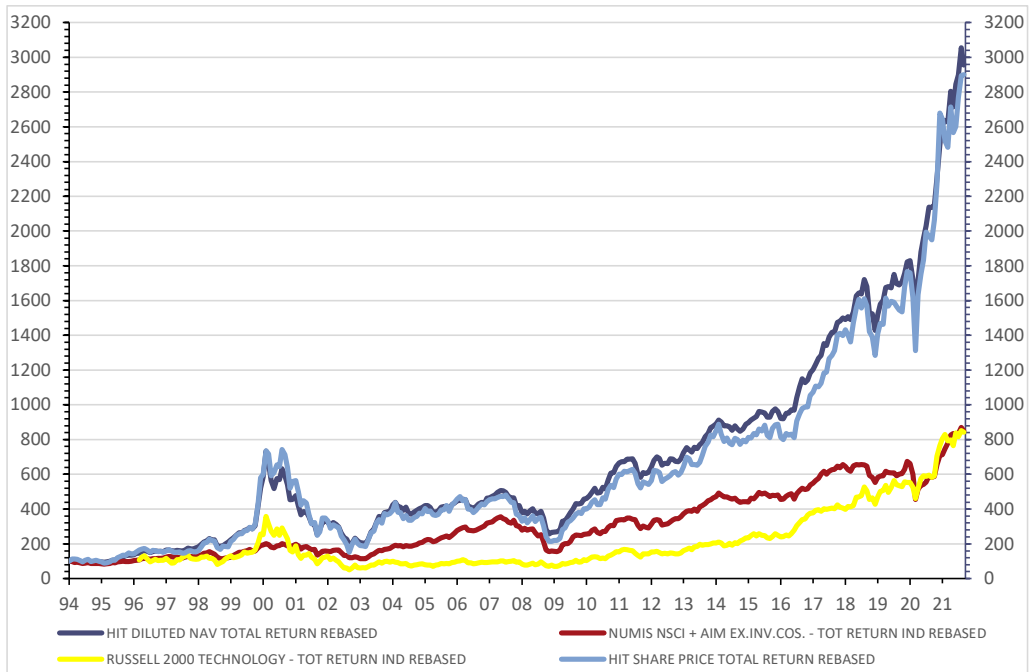

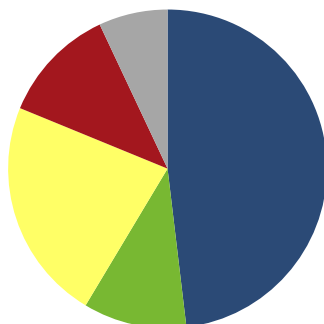

### Important Information
