The Herald Worldwide Technology Fund (HWTF) is an Open Ended Investment Company (OEIC) that seeks to achieve capital growth, in excess of the average, by investing in quoted companies in the technology, communications and multi-media sectors. As its name suggests, the Fund invests in companies worldwide, but especially North America and the UK.

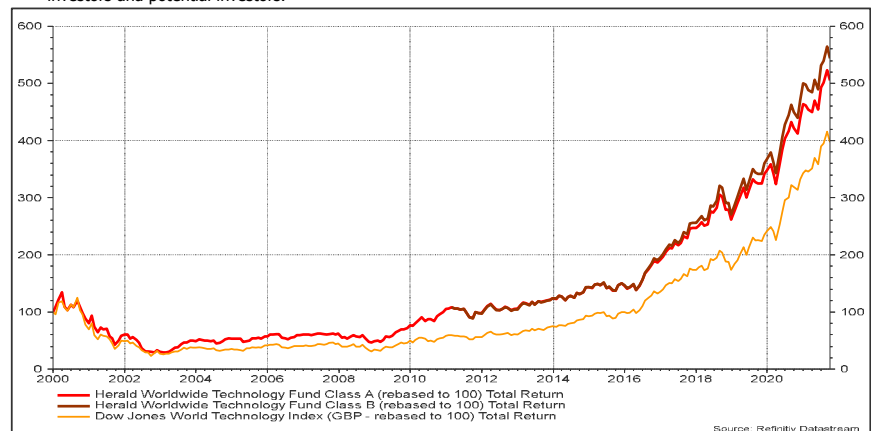

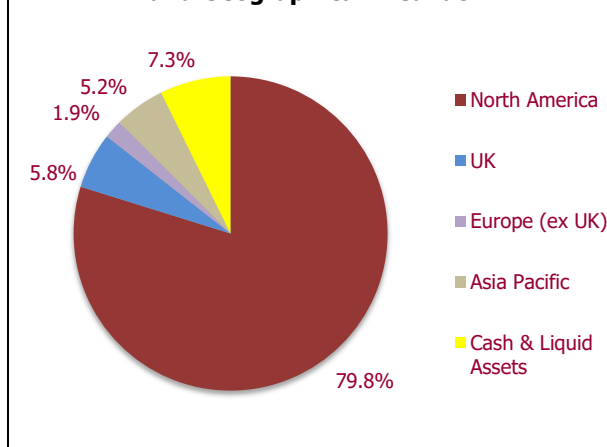

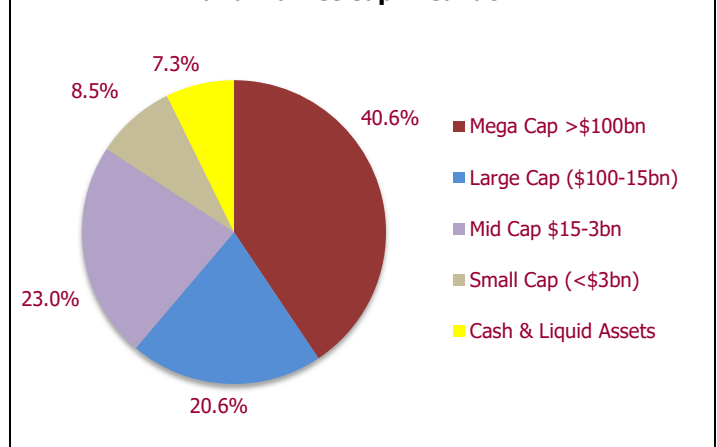

Fund Manager Comment

The top positive contributors to performance in September were Match Group, Tower Semiconductor, and Fabrinet. The main negative contributors to performance were Alphabet, Microsoft, and Apple. Despite the pullback in September, Alphabet, Microsoft, and Apple are three of the four best contributors to performance YTD. Duration and sustainability of inflation remains a concern across markets and is weighing on valuations. These are concerns we share. Based on our meetings with management teams, demand across diverse end markets remains robust. However, for those selling hardware, supply chains issues remain and are notably more pronounced than last year. At the same time, employee retention and productivity challenges caused by dispersed teams are becoming more prevalent.

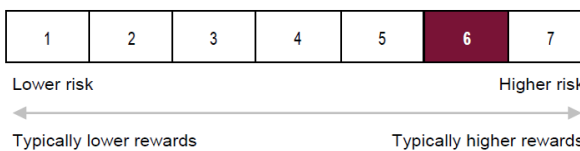
